

## **ASSESSMENT TESTS**

The student will be required to answer FIVE ASSESSMENT TESTS given periodically on E-mail of the student. The same will have to be answered WITHIN ONE MONTH. Next Assessment test will not be sent until the earlier is answered. All tests will be objective and short answers in a line or two. Lengthy answers will not be evaluated. Cut-copy-paste methods will be rejected and NO marks will be granted. Each test will carry 100 marks.

No individual Assessment test mark sheets will be sent to the students. Marks will be aggregated at the end of the program and the marks transcript will be enclosed with the Diploma.

Note: When a student applies for a job or any University for further advanced courses the school will be asked to provide acopy of the Mark scripts direct to them. Universities will ask for verification of genuineness of the Diploma. All such services will be charged by the School including Courier charges wherever required. The student will be asked to remit online such amounts as raised in the Invoice. Only after receiving the payment this facility will be completed.

## **DURATION**

The Program is designed under the UK pattern of Flexible Learning Convenience, that is, there are no fixed scheduled periodic examinations like the conventional system. The formal duration of the Program is One Year But can be completed earlier depending on completion of all academic formalities.

## MODE OF LEARNING

## PRESENTATION OF A CASE STUDY

The student will have to submit a simple case study of any business under MSMEs (Micro, Small, and Medium Enterprises). This should include nature of business and other details. This need not be an Islamic Business or businesses of any particular community. The School will assist in this. As the information required will be considered sensitive by business owners the name of enterprise and other details may be changed. This study should be about 20-30 pages with data, photographs, illustration etc.

# ALLOTMENT OF MARKS AND FINAL GRADE

Each assessment test will be of 100 marks aggregating to 400 marks, Case study will be allotted 100 marks, the total will be 500 marks and the same will be reduced to 100 for percentage basis.

Below 60 F - FailureGrade


## DIPLOMA AWARD AND ISSUE

On successful completion of the curriculum and obtaining a Pass grade the student will be awarded the Post Graduate Diploma in Islamic Business Management. The format will be decided by the Board of management. The student will be sent the Diploma in PDF format with insignia signature of the Dean by E- mail. The student can take a printout as per the specification provided with the Diploma with no changes in size and quality of card and thickness to maintain uniformity and standard.



## REGISTRATION PROCEDURE

Candidate may download the E Prospectus and Registration Form. After going through the same the candidate may fill up Registration Form with all the prescribed details and e mail the same to the School e mail ID. The Course fee should also be remitted simultaneously with the Form .Candidates should not upload any educational certificate along with the Form.
